Dear Peter-

Flattery aside (and Lagree completely) it's clear DivSeek needs the USDA's expertise and ideas....any one of the short CG presentations during the afternoon's technical meeting could have been given by many excellent USDA projects in genomic characterization of collections and data management. The NSF's iPlant presentation was the high point for me.

Actually, ARS staff would have delivered superior presentations compared to those from the CG Centers. They were quite disappointing (I'm not the only one who thought so). Basically" "Here's our wonderful work, give us some money!" rather than "We have this compelling idea for how to accelerate progress for the entire community!" But the CG Centers have plenty of \$\$ now. Yes, I thought that Laura Cooper's (OSU) and the iPlant presentation were high points.

The benefit of the USDA is to be at the table and to engage in the collaborative creation of this ambitious project...not for the promise of financing of projects (we will never see a dime) but for the PR that actively demonstrates our global leadership in our Agency's mission. That's the impact payoff . ..something our stakeholders are made aware of as they go to bat for us in Congress. Without it, we sink ever further below the radar. The result is we appear to cede mission passively...like when we had senate staffers coming out to find out if we *had* a gene bank after hearing about the Doomsday Vault in Svalbard!

Exactly, and that's why I'm most pleased that ARS can likely participate in DivSeek (presuming that the charter we adopted remains unchanged). It will enable us to influence the scientific agenda of institutions internationally, and hopefully elevate the Agency's profile.

Not sure why we are in this (shadowy) position vis à vis the GCDT especially since their stated aim is to develop a *unified* front. The other article in that issue of Science about the DivSeek meeting emphasized the 15 CG sites to the exclusions of all others. The combined ARS research capacity is, in fact, the 800lb gorilla sitting in the room (mostly) ignored by the European and CGIAR institutions during these sessions. It's been a role that has evolved even as our system distributes so much of the world's PGR (which is always a source of pride for me!). Perhaps it's our difficulty negotiating these complex multilateral treaties like the ITPGRFA? At any rate the NPGS should be squarely at the forefront of these kinds of initiatives, especially ones that anticipate how it is we staff (the next generation of) curators to utilize the data deluge which is coming. I think it's a pivotal opportunity to develop this capacity in our germplasm system. I think Theo said it best: unless we engage by developing a cadre of folks capable of interpreting these data to serve the needs of curators, they will continue to merely be those nice, dedicated people relegated to working away in the cold basement tending the seeds!

Yes, the heavy emphasis on the CG Centers was a bit disconcerting: I believe that it caused the nonapproval of the membership proposed for the Steering Committee. It was just too heavily skewed to the CG Centers. Robbie Waugh handled that rather deftly, I thought.

The GCDT is undergoing a transition, driven by funding needs and other factors. Their funding target is now \$500 million, up from \$250 million, probably driven mainly by the minuscule earnings from interest on investments. The US Senate is responsible for the US donating lots of \$\$ to the Trust via USAID; that sum will likely not increase in the future. So, they need to attract other donors, with Europe probably the most fertile hunting grounds. Add that to the re-location to Bonn, the new European director Marie Haga, and continued strong support from Norway and Germany, and the Trust appears more Eurocentric than during Cary's tenure. That said, we (USAID, USDA) are frequently consulted on key issues, and we continue to wield quite a bit of clout behind the scenes. That was evident from the success of the DivSeek meeting. DivSeek has much potential for magnifying our influence.

These are strictly my opinions here, Peter. I hasten to add that they are quite myopic sitting here in my own cold basement in Fort Collins....!

### Not myopic at all. I too loved Theo wry comment about the kind people in basements!

## Guidelines and Template for the Review of the Draft DivSeek Charter

## I. Background

1. The DivSeek scoping meeting in April 2014 mandated a working group on governance and legal issues to develop the formal governance structure of DivSeek.

2. As advised by the working group, the DivSeek Joint Facilitation Unit circulated a letter calling for non-binding expressions of interest in DivSeek. Organizations that signed the expression of interest, are invited to the first DivSeek Partners' Assembly on 9 January 2015.

3. As anticipated in the letter calling for expressions of interest, the working group has developed a draft Charter setting forth the principles and institutional mechanisms of DivSeek, for consideration and approval by the first DivSeek Partners' Assembly.

4. The draft Charter is circulated before the DivSeek Partners' Assembly for comments. This document provides guidance on submitting comments on the draft Charter.

5. The comments received will be compiled, fully referenced and circulated before the Assembly, together with a synthesis report.

6. The Assembly is exclusively responsible for reviewing and approving the draft Charter. During the Assembly, experts of the working group on governance and legal issues may suggest textual changes to the draft Charter, for the consideration of the Assembly.

7. The text of the draft Charter is provisional and subject to the approval of the Assembly. It shall not be published, displayed, re-transmitted in any manner, quoted or cited in any publication, website or network.

- c. Please clearly indicate if you are submitting general comments or comments on a specific line of the Charter.
- d. In areas where you feel additional or alternative text is required, please suggest, if possible, *what this text may look like* or *what should be included*.
- e. Please avoid commenting on issues related to grammar, spelling, or punctuation, unless it affects the overall meaning of the text, as the Charter will be edited.
- f. If you refer to additional sources of information, please include these with your comments when possible or provide a complete reference or hyperlink.

## Draft DIVSEEK Charter

5 This Charter defines the general conditions for the operation of DIVSEEK and sets forth the 6 governance structure for voluntary cooperation by Partners. This Charter does not create 7 any legally binding obligation between or among Partners.

8 The DIVSEEK First Assembly approved this Charter on 9 January 2015 in San Diego (USA). The
9 list of organizations represented at the Assembly is in Annex A.

#### Background

Meeting the food needs of a growing human population in an era characterized by climate change and increased competition for land and water is a key global challenge. Crop production must rise, and crops must become more resilient to an increasingly unstable climate to produce sufficient nutritious food and other agricultural products in a sustainable manner. Natural variation from genetic resources is the raw material for crop improvement, and thus must be a critical component of any comprehensive strategy to address food security and the sustainability of agricultural production.

19 Until recently, it was difficult to systematically characterize and utilize the genetic resources 20 that make up crop diversity. However, game-changing technologies and big-data approaches 21 now enable a comprehensive approach to genetic resources, using existing but dispersed capacities of genebanks, breeders, researchers, farmers and other stakeholders, to respond 22 23 to global research priorities. In recent years a number of crop-specific projects have been 24 initiated in this new sphere. In an attempt to link these unconnected efforts DivSeek was 25 initiated, as a voluntary association of like-minded partners harnessing genetic resources for 26 food security to create synergies that would benefit most stakeholders and hence accelerate 27 the unlocking of the untapped value of genetic resources for the benefit of sustainable 28 intensification and climate proofing of global agriculture.

#### Mission

The mission of DIVSEEK is to cross-link, support and add value to individual projects that harness the power of crop diversity for food and nutritional security by enabling breeders and researchers to broadly mobilize natural, useful genetic variation in order to accelerate crop improvement.

#### Principles

DIVSEEK aims to bring together a broad array of partners on a voluntary basis to **facilitate networking** among otherwise disconnected efforts to harness genetic resources for crop improvement and to ensure the continuous relevance of their outputs for the targeted beneficiaries. DIVSEEK is a **community-driven** and **inclusive** initiative open to all institutions from all relevant sectors, including public, private, academic, civil society and intergovernmental organizations. Any organization can become a Partner by accepting this Charter in writing.<sup>1</sup>

9 DIVSEEK advocates the application of state-of-the-art genomic, phenotyping and phenomic 10 technologies to enhance the quality, efficiency, and cost-effectiveness of germplasm 11 conservation, provision and utilization for breeding, to **deepen our understanding of crop** 12 **diversity** and to stimulate public interest in the role of genetic diversity for crop 13 improvement.

14 DIVSEEK facilitates the **linking of germplasm with characterization data** through the 15 promotion of common data standards and best practices designed to enable interoperability 16 among information systems, to broaden the usability of data and germplasm, and to support 17 open access to germplasm-associated data.

18 DIVSEEK follows a **modular approach** to information management which aims to define and 19 maintain a set of core standards for data exchange to enable data integration and 20 interoperability among continuously evolving and potentially diverse platforms and data 21 domains. This approach reduces transaction costs, allows for effective 'rights management' 22 at a level of discretion determined by individual stakeholders, and allows stakeholders to 23 absorb and adapt to new requirements and rapidly changing technologies.

DIVSEEK contributes to on-going international cooperation for the developing and strengthening of a **global information system**, to facilitate the exchange of information on scientific, technical and environmental matters related to plant genetic resources for food and agriculture.

DIVSEEK recognizes the importance of **understanding the needs and capacities** of stakeholders such as genebanks, breeders, researchers and farmers to define priority areas for germplasm characterization and data access. DIVSEEK offers opportunities for publicizing critical needs and facilitating cross-crop learning and capacity development and training to apply cutting-edge tools and approaches to both impact-oriented and discovery-driven research on plant genetic resources.

To implement the actions and principles set forth in this Charter, DIVSEEK may elaborate operational guidelines, including through broad-based **expert consultations**.

Partners are organizations that support DIVSEEK's mission by associating specific activities

Changes to this Charter shall only be possible with the consensus of the Assembly, with at least three quarters of the Partners present.

The Assembly and the Steering Committee may establish rules of procedure for their meetings. Such rules of procedures may provide for matters such as: a) notice and record of meetings; b) decision making (e.g., where consensus cannot be reached) and recording of

1. The DivSeek scoping meeting in April 2014 mandated a working group on governance and legal issues to develop the formal governance structure of DivSeek.

2. As advised by the working group, the DivSeek Joint Facilitation Unit circulated a letter calling for non-binding expressions of interest in DivSeek. Organizations that signed the expression of interest, are invited to the first DivSeek Partners' Assembly on 9 January 2015.

3. As anticipated in the letter calling for expressions of interest, the working group has developed a draft Charter setting forth the principles and institutional mechanisms of DivSeek, for consideration and approval by the first DivSeek Partners' Assembly.

4. The draft Charter is circulated before the DivSeek Partners' Assembly for comments. This document provides guidance on submitting comments on the draft Charter.

5. The comments received will be compiled, fully referenced and circulated before the Assembly, together with a synthesis report.

6. The Assembly is exclusively responsible for reviewing and approving the draft Charter. During the Assembly, experts of the working group on governance and legal issues may suggest textual changes to the draft Charter, for the consideration of the Assembly.

7. The text of the draft Charter is provisional and subject to the approval of the Assembly. It shall not be published, displayed, re-transmitted in any manner, quoted or cited in any publication, website or network.

8. The draft Charter is transmitted together with this document, in a portable document format (PDF).
